Compliance with sanitary measures:

Based on the recommendations and standards established by the WHO and/or national/territorial authorities for the control of diseases with risk of contagion, including epidemics/pandemics, the visitor undertakes to strictly comply with the protocols that are implemented at all times. to ensure health and safety. Right of admission (general access limitations):

- People who want to enter once the maximum authorized capacity has been exceeded.
- If the people who want to access the fair have a behavior or attitude that hinders the normal development of the show or activity.
- People who express violent attitudes or who publicly incite hatred, violence or discrimination based on birth, race, sex, religion, opinion, disability, sexual orientation, gender identity or any other social or personal condition or circumstance, and, especially, those who behave aggressively or cause disturbances outside or at the entrance, those who carry weapons or objects that could be used as such and those who wear clothing, objects or symbols that incite violence. violence or represent advocacy of activities contrary to the fundamental rights recognized in the Constitution.
- Only people who belong to State security forces and/or private security services that are in the area in the exercise of their functions may be allowed to carry regulatory weapons.
- When people who want to access or remain in the place endanger or cause inconvenience to the rest of the spectators or attendees.
- To people who show symptoms of drunkenness or who are consuming drugs or narcotic substances or show symptoms of having consumed them.
- It is essential to be accredited to access the Hall.
- The Organization reserves the right to admit people as well as the right to verify their identity and is authorized to withdraw their accreditation/ticket due to non-compliance with the Hall's Access Rules, without refund of the amounts paid for the purchase of said accreditation/ticket. entrance.

- Entry to the Fair is exclusive for professional visitors. Entry to minors under 16 years of age is not permitted, neither alone nor accompanied.
- The visitor pass is nominal, personal and non-transferable and it is mandatory to always carry it clearly visible.
- Street sales or unauthorized distribution of advertising are not permitted.
- Access with carts or taking possession of products on display is not permitted. In case of non-compliance, the Organization will have the power to withdraw the accreditation/entrance, and must leave the premises.
- Access with animals is not allowed, except in those cases legally provided for (guide dogs, security dogs)
- Access with bicycles, scooters, skateboards and similar is not permitted.
- Smoking is not allowed inside the pavilion or in closed areas.

For security reasons, and in some of the fairs, there is access control using an X-ray scanner.

Items that must go through the scanner:

- Jackets and coats
- Laptops and tablets out of their case.
- Hand luggage (suitcases, briefcases, bags, etc.)
- Goods that, due to their opacity, can only be verified through X-ray control equipment.

The security guard in charge of the scanner may require the suitcase or backpack to be opened for a second check if the image is not clear.

Suitcases or backpacks that, due to their dimensions, cannot be verified through X-ray control equipment. They must be verified by opening them, with the consent and permanent supervision of the owner and in a private space enabled for this purpose. If you refuse, the owner will not be able to access the Lounge with said suitcase or backpack. The venue will have a voluntary cloakroom service for objects verified by the security team.

Prohibited objects that are not expressly authorized:

- Chemical and toxic substances. Explosive and incendiary substances and devices.
- Devices that fire projectiles.
- Sharp-edged or cutting objects. Objects with obtuse endings (stick, baseball bat, etc.). Arms.
- Stunning or immobilizing devices.
- Any tool or object that could be used to cause serious injury.
- In the case of goods that, due to their size, cannot be verified by the scanners, the presence of the person in charge of the stand will be required to, if applicable, open the package for verification and authorization.

The Organization reserves the right to adopt any other measure conducive to the best order, operation of the Fair and protection of the rights of exhibitors and visitors.
